Biological and organic prevention methods are employed, and pesticides are used as a last resort, primarily during vegetation, including the following preventative applications: Citric Acid, Corn Oil, Extract of Reynoutria sachalinensis, Hydrogen Peroxide, Mineral Oil. All applications are approved by the OMMCP.
