

How to Get a Medical Marijuana Card in Ohio

With the passing of [Ohio House Bill 523](#) in 2016, residents in the Buckeye State have the excellent opportunity to choose medical marijuana for treatment of their qualifying conditions. The **Ohio Medical Marijuana Control Program (OMMCP)** has established a simple application process for eligible patients to register for access to the Ohio medical marijuana market.

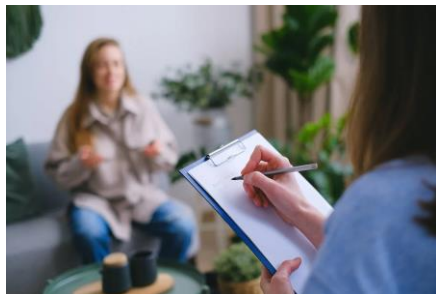
Current Qualifying Conditions

- o AIDS
- o Alzheimer's disease
- o Amyotrophic lateral sclerosis
- o Cancer
- o Cachexia
- o Chronic traumatic encephalopathy
- o Crohn's disease
- o Epilepsy or another seizure disorder
- o Fibromyalgia
- o Glaucoma
- o Hepatitis C
- o Huntington's Disease
- o Inflammatory bowel disease
- o Multiple sclerosis
- o Pain that is either chronic and severe or intractable
- o Parkinson's disease
- o Positive status for HIV

The Ohio Medical Marijuana Application Process

First, schedule an appointment with a physician certified by the **OMMCP**. You can find an up-to-date list of qualified doctors [here](#).



The physician's office will verify your eligibility by requiring a valid government ID, proof of residency, and requesting a copy of your medical records indicating a qualifying condition. Patients under the age of 18 must have a qualified caregiver 21 years or older.

During the appointment, your doctor can answer any questions you may have about medical marijuana therapies and your qualifying condition(s). Many qualified physicians offer convenient telehealth appointments.

After the appointment, your doctor will register their recommendation for you with **OMMCP** Patient Registry and create a patient profile. You will then receive an email with a link and instructions on how to complete your application and pay the registration fee online.



The annual cost of Ohio's medical marijuana registration is \$50 for patients and \$25 for caregivers. Patients with indigent or veteran status can find information about reduced fees [here](#). Recommendations and registration are valid for one year.

You will receive a printable *digital* copy of your Ohio Medical Marijuana Registry card once your finalized application has been approved by the Ohio State Board of Pharmacy.
